Information Used or Gathered on the SJC Website

Every effort is made to ensure that confidential information is secure and that any information gathered is used appropriately. The following describes what information is used or collected and how it is protected.

Personal Information:

SJC collects Personally Identifiable Information (PII) only when the visitor provides this information directly to SJC, such as by voluntarily submitting a form, creating an account, registering for classes, responding to surveys, or completing the online admission application. SJC may also collect information through voluntary interaction with SJC's social media platforms.

SJC may use PII to communicate with you about academic programs, events and other news at SJC. SJC may partner with outside vendors to provide certain services on our behalf, such as



but not limited to, email and mail distribution, fulfillment and shipping. These third-party vendors will have access to the information needed to perform their functions but may not use that information for any other purpose.

Any time that a user logs into SJC resources with their SJC account, the username and password entered are secured. Similarly, any transfer of private information on SJC websites is secure. This means that any data sent from the user's internet browser to SJC servers and cloud software (and vice versa) is encrypted.

Information Used to Analyze Web Traffic Patterns:

San Juan College uses Google Analytics to collect various data about visitors to SJC websites. It is only used to assist San Juan College in determining areas of interest and usability of SJC websites. Examples of this information include, but are not limited to:

- The IP address from which you access our website.
- The name of the domain from which you access our website.
- The pages, files, documents, and links that you visit.
- The type of browser that you used to access our website.
- The date and time you accessed our website.
- The website address that referred you to our site by clicking on a link.

Cookies:

Cookies are small files that are downloaded to your device when you visit a website. These files are used to improve the user's experience on a site or customize information for individual users. Cookie data is not used to collect personally identifiable information of visitors to SJC websites. San Juan College uses Google Analytics, Google Advertising, Google Signals, Google Tag Manager, Google Search Console, and other relevant Google Analytics Advertising Features. Remarketing and Conversion Pixels:

Remarketing and conversion pixels are placed on San Juan College's website for the use of digital advertisements, including in-app advertisements and paid keyword searches. In addition, these pixels allow San Juan College to advertise to past website visitors. San Juan College's digital advertisements are served to users through third-party vendors (including, but not limited to, Facebook and Google AdWords) and ads may be seen on sites across the Internet. These third-party vendors may use cookies to serve you more relevant advertisements based on information about your visit to our website or other websites.

Chat Feature:

SJC makes some chat features available to its users. Any information shared through a chat feature could become public information. Therefore, please do not disclose any personal information in these areas.

Surveys:

A number of surveys may be found on SJC websites at any time. Unless indicated otherwise, any confidential information gathered in a survey is only used for the purposes of the research being conducted. Unless otherwise noted, responses given in a survey are not connected to individual users in any way. Aggregate data from surveys may be shared with external third parties.
